"An immigrant friendly business environment is a key factor to economic success and business growth," stated Chris Kershner, Vice President of Public Policy and Economic Development at the Dayton Area Chamber of Commerce. "We appreciate efforts being undertaken that will strengthen the entrepreneurial immigrant opportunities and allow for immigrant owned businesses to flourish. Immigrant owned businesses are seeing significant successes in the Dayton area, and we want to ensure this continues."

On Thursday, January 30, Congressional Republicans released their long-awaited outline recognizing the need to fix the country's broken immigration system, detailing their blueprint for reform.

"It is reassuring to know that bi-partisan action at last seems to be moving us toward modernization of the immigration system, including citizenship opportunities for DREAMers," said Matt Joseph, Dayton City Commissioner. "We have worked hard to make Dayton a welcoming city and we look forward to progress on a national level."

Dayton Police Chief Richard Biehl highlighted the impact immigration policies have on community safety, "For 35 years I have worked to improve public safety in urban areas, and know from experience that effective public safety depends on the engagement and support of citizens. I believe that the House Republican principles are an important step toward an immigration reform process that could make local law enforcement more effective and communities across America safer."

"Reforming our broken immigration system is critically important to economic growth, creating jobs, and ensuring the U.S.' continued global competitiveness," Joe Green, Founder and President of FWD.us said. "We believe the time for reform is now, and we join Americans of all backgrounds in calling for passage of reform in 2014."

The GOP principles include:

- Border security and interior enforcement;□
- Implementing an entry-exit visa tracking system;□
- Implementing employment verification and workplace enforcement;□
- Reforming the legal immigration system;□
- Providing an opportunity for legal residence and citizenship for those who were brought to this country as children;□
- Addressing individuals living outside the rule of law
